New owner agrees to have animal vaccinated against rabies and other necessary shots yearly. Dogs must be kept on monthly heartworm preventative. **THIS IS MANDATORY!** To provide adequate food, water, shelter, exercise, medical care and general care for the animal in a loving and humane manner. New owner specifically agrees this animal will not be allowed to run at large inasmuch as it could endanger itself or other animals or people. I agree that when this animal is not confined behind a fence, a person physically capable of controlling the animal will control it. **I agree not to tie or chain this animal** as a means of confinement. New owner agrees not to allow this animal to be used for research purposes. Owner agrees to hold Fayette County Animal Rescue harmless against all accidents, damages, and injuries to person or property of any family member, guest, invitee or employee of the adopter caused by or resulting from or in connection with the adopted animal. New owner further agrees to hold the aforementioned party harmless against any illness; disease or problem the animal may have or develop after 30 days of adoption. *If animal becomes sick within the first 30 days owner agrees to call FCAR for further instructions. FCAR will cover medical expenses during the first 30 days at FCAR approved facility.* Owner agrees to attempt to correct any behavioral problems the pet may develop using humane and animal friendly methods before surrendering pet. *Rescue animals need training.* Owner agrees to return animal within 30 days if he/she finds the animal not compatible with their environment or Owner does not follow above requirements. Owner agrees to never turn over animal to any animal shelter other than FCAR. Adopter agrees to pay and reimburse FCAR for any and all legal fees and court costs it incurs in enforcing the terms and conditions of this agreement. Adopter will pay FCAR \$500.00 as liquidated damages in the event Adopter breaches any of the provisions of this agreement. Adopter agrees that FCAR shall in addition to the collection of such liquidated damages, retain all of the other remedies, including, but not limited to, the inspection and reclaiming of the animal, provided for in this agreement and allowed at law or in equity. This agreement contains no express or implied warranties of merchantability or express or implied warranties that the animal adopted by the Adopter is fit for any particular purpose. The laws of the State of Tennessee shall govern this agreement. In the event that any term, provision or paragraph of this agreement is declared illegal, void or unenforceable, this shall not affect or impair the other terms, provisions, or paragraphs of this agreement. The doctrine of severability shall be applied. **No Refunds after 30 days.**
